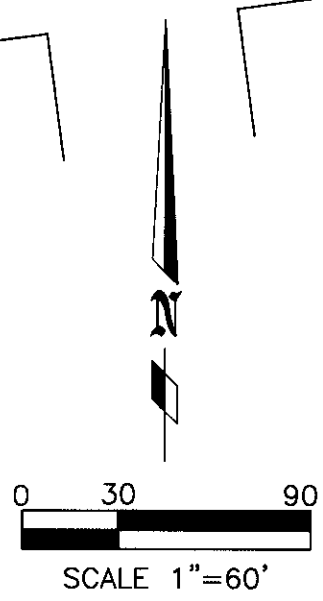
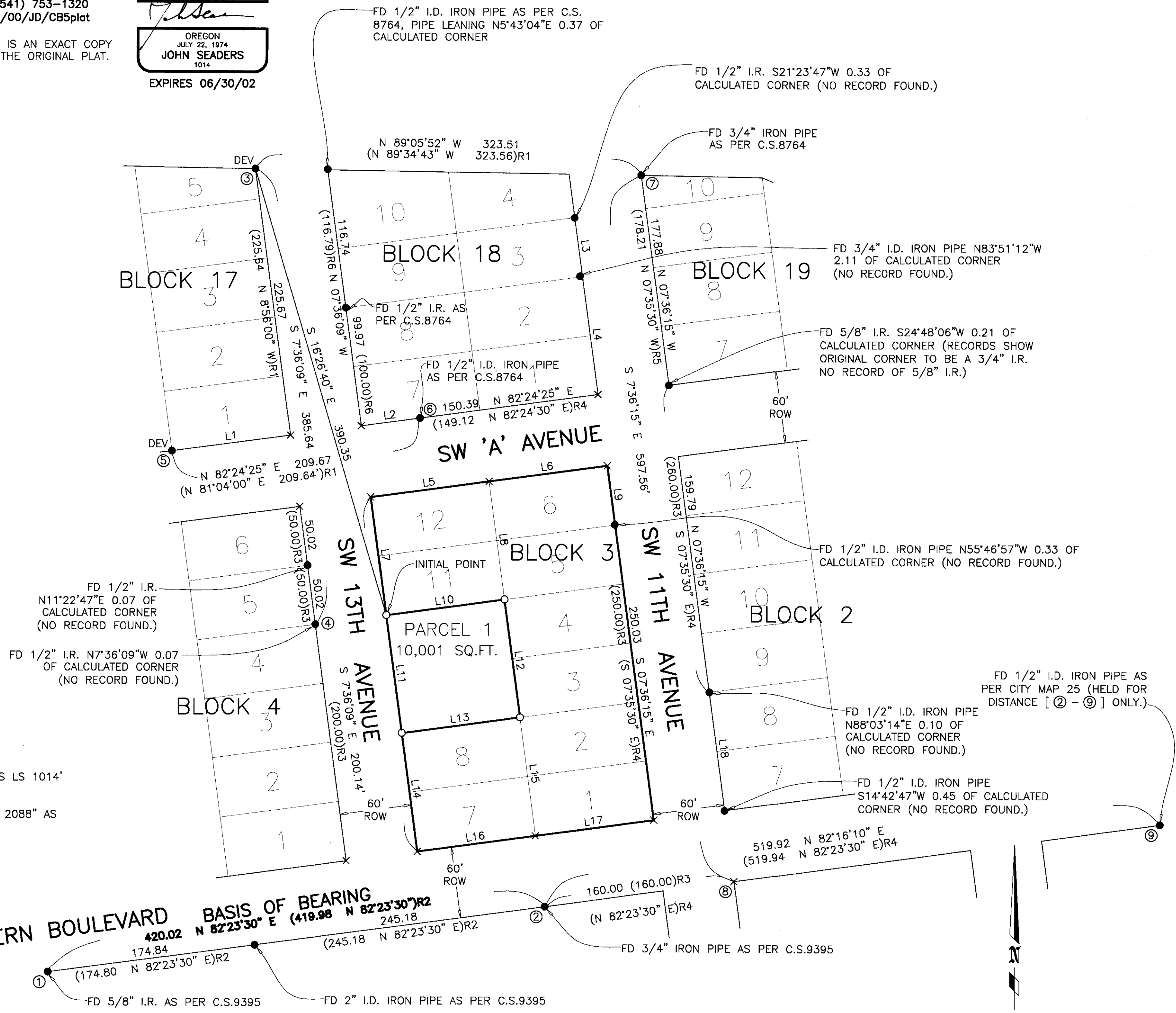

**SURVEYOR'S NARRATIVE:**

THE PURPOSE OF THIS SURVEY WAS TO JOIN INTO ONE PARCEL LOTS 9 AND 10 OF BLOCK 3 OF "AVERY AND WELLS'S ADDITION TO THE CITY OF CORVALLIS" OWNED BY NOITION INVESTMENT LIMITED, LLC. I HELD ① AND ② AS THE BASIS OF BEARING AS PER C.S. 9395 AND PARALLELED THE LINE BETWEEN THOSE TWO POINTS 60 FEET TO THE NORTH TO ESTABLISH THE SOUTH BORDER OF BLOCK 3. I HELD ③ AS PER C.S. 8764, AND ④ EXTENDED THE LINE BETWEEN THEM TO THE SOUTH, AND PARALLELED SAID LINE TO THE EAST 60 FEET TO ESTABLISH THE WEST BORDER OF BLOCK 3. I HELD ⑤ AND ⑥ AS PER C.S. 8764, EXTENDED THE LINE BETWEEN THEM TO THE EAST, AND PARALLELED SAID LINE TO THE SOUTH 60 FEET TO ESTABLISH THE NORTH BORDER OF BLOCK 3. POINT ⑧ WAS CALCULATED BY STARTING AT ② AND PLACING SAID POINT 160 FEET TOWARDS ⑨ ALONG THE SOUTH RIGHT-OF-WAY OF SW WESTERN BOULEVARD. I HELD ⑦ AND ⑧ AND PARALLELED THE LINE BETWEEN THEM TO THE WEST TO ESTABLISH THE EAST BORDER OF BLOCK 3. I DIVIDED THE WEST BORDER OF BLOCK 3 INTO THREE SEGMENTS OF EQUAL LENGTH, ESTABLISHING THE MIDDLE SEGMENT AS THE WEST BORDER OF PARCEL 1. I CREATED A LINE FROM THE MIDPOINT OF THE NORTH BORDER OF BLOCK 3 TO THE MIDPOINT OF THE SOUTH BORDER OF BLOCK 3. I DIVIDED SAID LINE INTO THREE SEGMENTS OF EQUAL LENGTH, ESTABLISHING THE MIDDLE SEGMENT AS THE EAST BORDER OF PARCEL 1. I ESTABLISHED THE NORTH BORDER OF PARCEL 1 BY JOINING THE NORTH ENDPOINTS OF THE WEST AND EAST BORDERS OF PARCEL 1 TO EACH OTHER. LIKEWISE, I ESTABLISHED THE SOUTH BORDER OF PARCEL 1 BY JOINING THE SOUTH ENDPOINTS OF THE WEST AND EAST BORDERS OF PARCEL 1 TO EACH OTHER. THE BOUNDARY OF THE PARTITION WAS ESTABLISHED BY THE MONUMENTS HELD AS SHOWN.

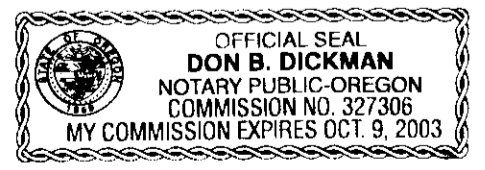
