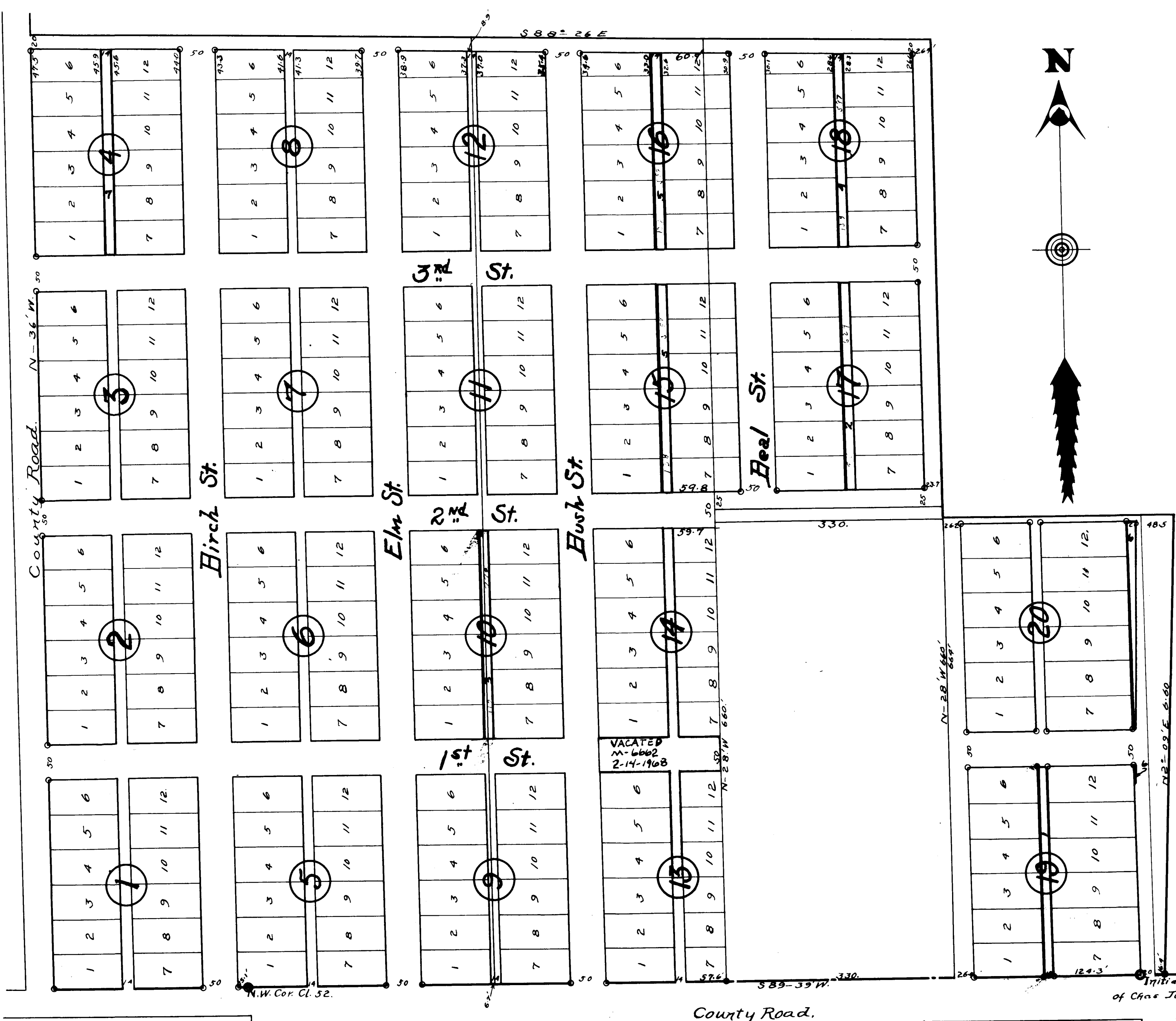


MAP of WEST CORVALLIS, OREGON.

I, J. Marion Wilkes, being first duly sworn, say: That I have correctly surveyed, and marked with proper monuments the lands as represented on the accompanying plat, which said lands are described as follows, to wit:

For an initial point, commence at the N.E. Corner stone of the D.L.C. of Chas Johnson, being Cl. N^e 52, Tp. 11 S. R. 5 W. of the Will. Mer. in Benton, Co. Oregon, and ran thence S. 89° 36' W. along said claim line 1198.3 ft. to a stone monument 12x8x6" under which there is driven a galvanized pipe 3/4" x 30". From which: The S.E. Corner of Blk. 14. Wells + Mc Elroy's add. hrs N 89° 36' E 36.4' " initial point of Millers Add. to Corvallis hrs. S 55° 28' E 50.4'

And from said initial point I ran S 89° 39' W. 264.7', thence N-28° W. 660', thence S 89° 39' W. 330', thence S-28° E 660', thence S 89° 39' W. 963.6', thence N-36° W. 1367.5, thence S 88-26 E. 1296.9, thence S-28° E 682.6', thence N 89-45 E 333.4, thence S 2° 09' W 660', thence S 89° 39' W 36.4' to place of beginning.

That I planted said stone monument, indicating said initial point, six inches below the surface of the ground.

All dimensions on said plat are given in feet and decimals of feet and the bearings are referred to the true meridian by an observation on the sun.
