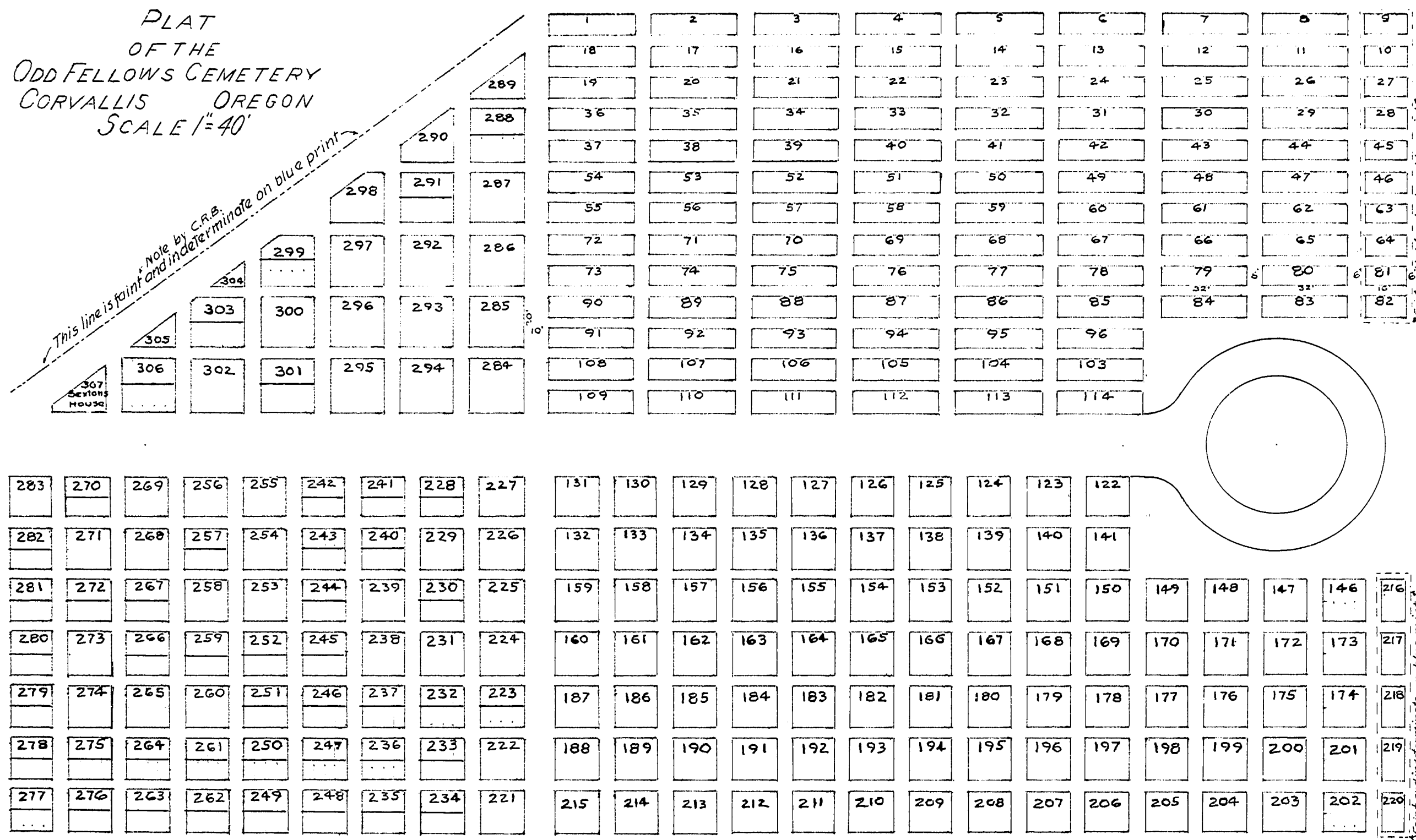
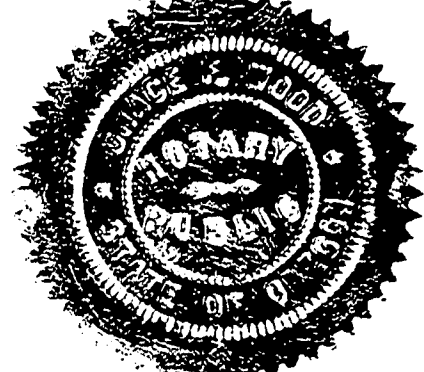


PLAT OF THE ODD FELLOWS CEMETERY CORVALLIS OREGON SCALE 1"=40'



Know All Men By These Presents:- That, whereas Barnum Lodge No 7, I.O.O.F. of Corvallis, Oregon is the owner of certain lands in Benton County, Oregon, acquired from A.M. Witham and his wife by a deed recorded in Book F, page 370 and by a deed recorded in Book J, page 352 of deed records of said County; and whereas said land has been used and is continuing to be used exclusively as a burial ground in accordance with a certain allotting diagram of said lands entitled PLAT OF THE ODD FELLOWS CEMETERY CORVALLIS OREGON; and whereas transfers of title for burial purposes have been made in accordance with said plat; and whereas burials have been made in accordance with such transfers: Then and therefore said Lodge, through its undersigned Board of Trustees and by these presents does present hereon for public record a true and faithfully shown copy of said hereon mentioned plat of said cemetery; and further be it known that said Lodge now and hereby reserves to itself exclusively the sole right to formulate, adopt and enforce rules of conduct, Bylaws and Regulations governing the financial, social and physical welfare of said cemetery.

In Witness Whereof C. Robert Hess and Floyd Spurlin and Emile E. Larkin the now duly elected trustees of and for said Lodge set their hands in assent to the filing for record of the hereon contained "Plat of the Odd Fellows Cemetery" aforementioned and do cause the Official Seal of said Lodge to be here to affixed.

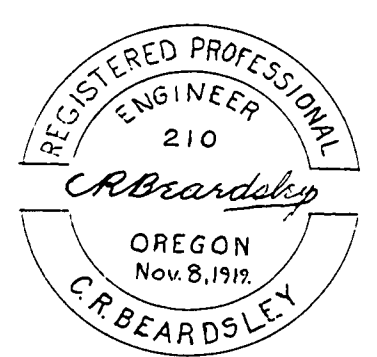

C. Robert Hess and said Floyd Spurlin and said Emile E. Larkin acknowledged this instrument to be the free act and deed of said Lodge.

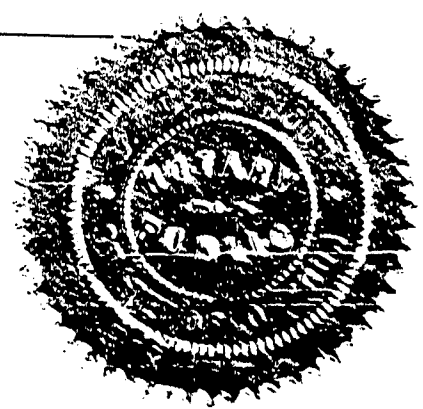

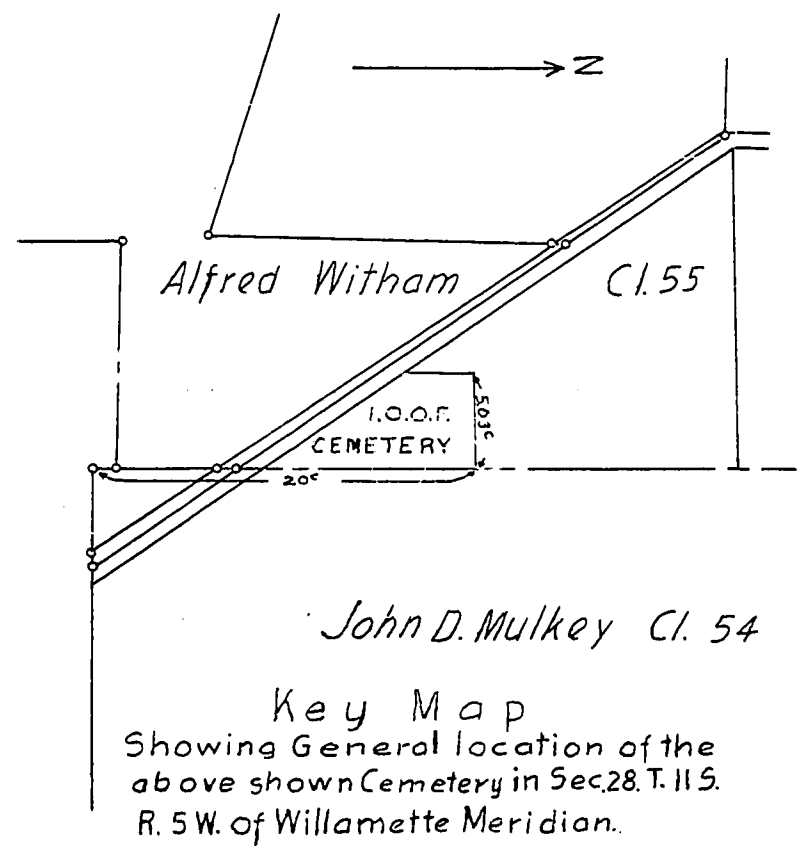
