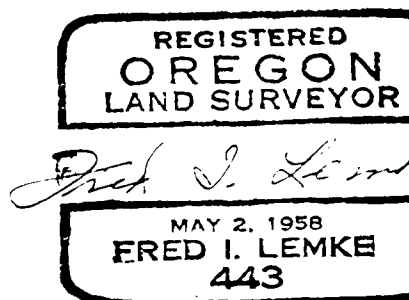

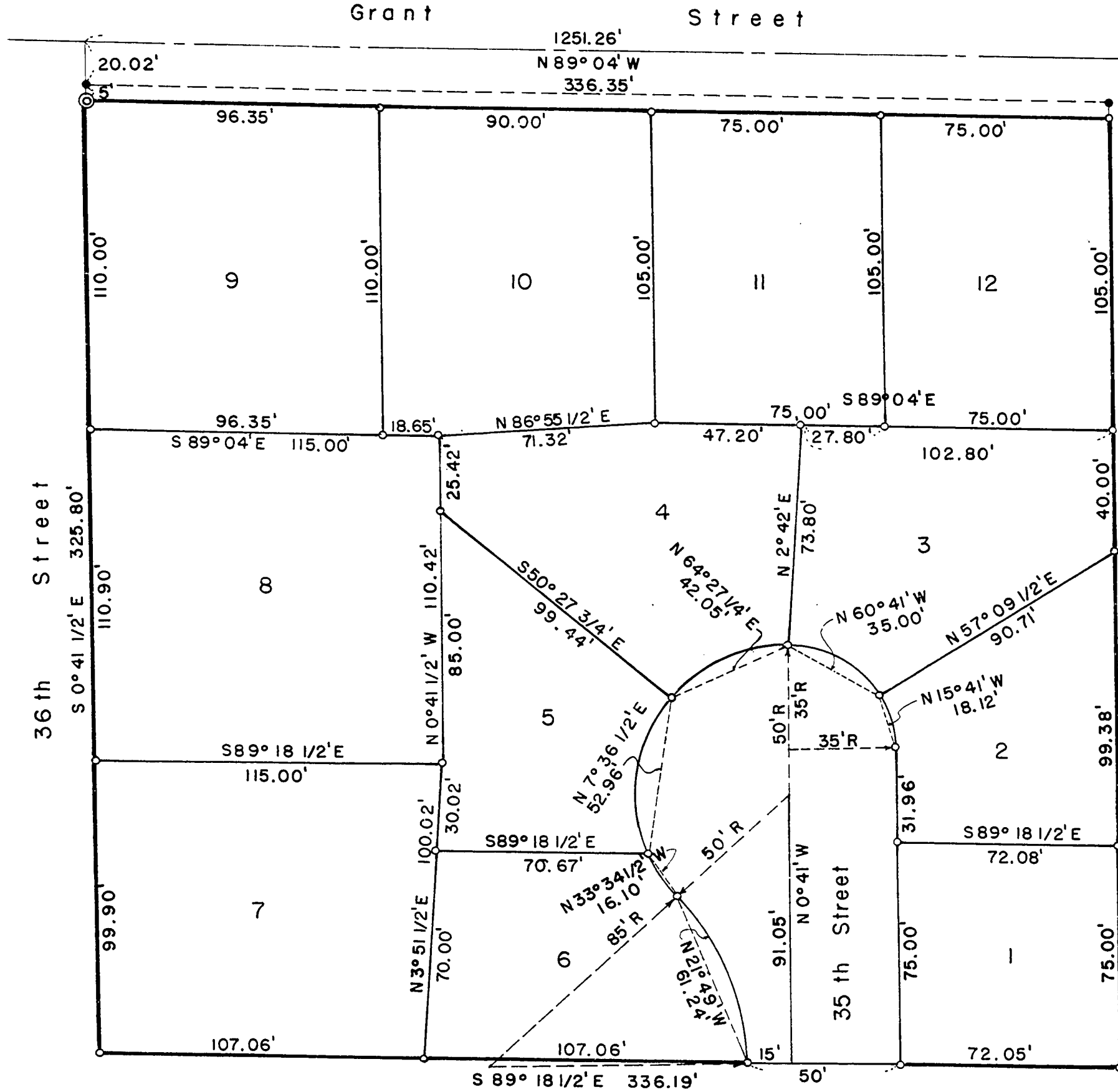
SURVEYOR'S AFFIDAVIT

I, Fred I. Lemke, being first duly sworn, depose and say that I have correctly surveyed, and marked with proper monuments, the land represented on the plat hereon; that as an initial point of said survey I drove a galvanized iron pipe 2 inches in diameter and 36 inches in length 6 inches below the ground, said point being, 1251.26 feet, along the center line of Grant Street, north 89° 04' west and 20.02 feet south 0° 41' 1/2' east from the southwest corner of the James L. Mulkey, Sr. Donation Land Claim No. 63 in Township 11 south, Range 5 west of Willamette Meridian in Benton County, Oregon; thence south 0° 41' 1/2' east, along the east line of 36th Street, 325.80 feet to the northwest corner of Ash Manor; thence south 89° 18' 1/2' east, along the north line of Ash Manor, 336.19 feet to the northeast corner of said subdivision; thence north 0° 39' 1/2' west 324.38 feet to the north line of Grant Street as now laid out; thence north 89° 04' west 336.35 feet to the point of beginning.
