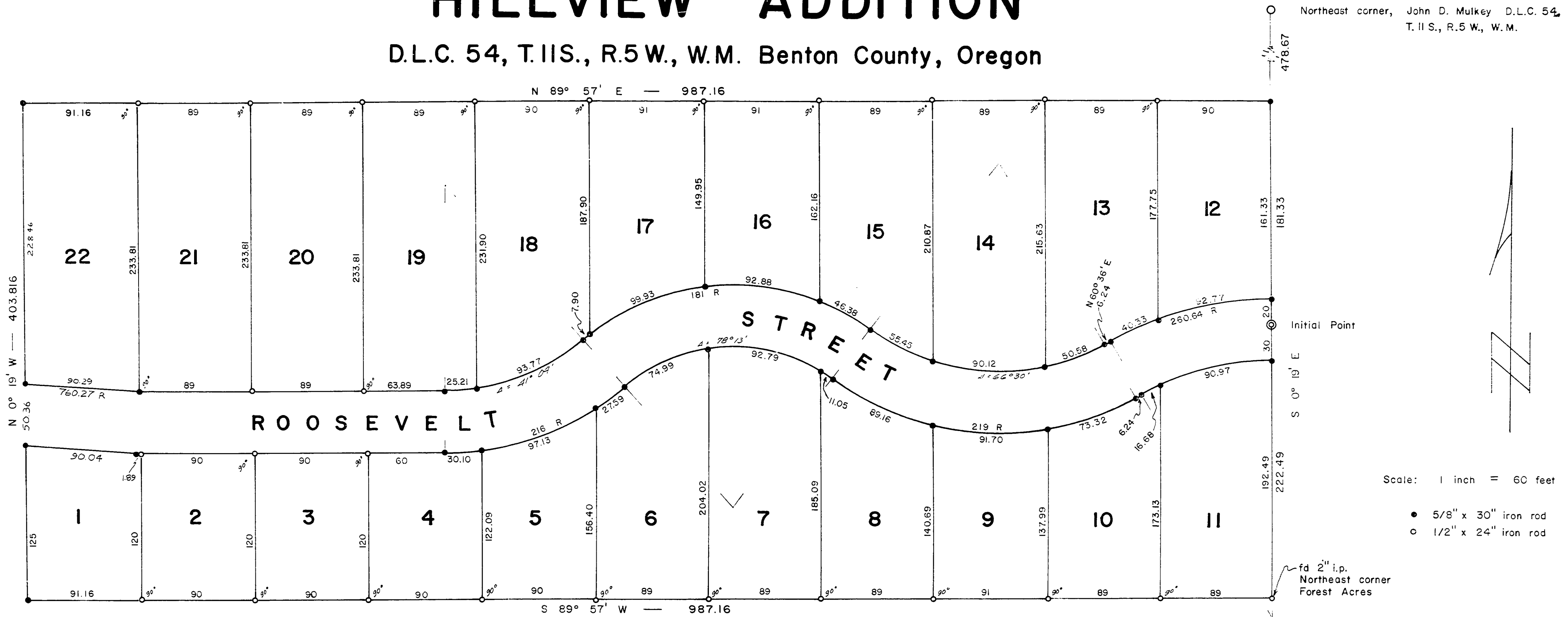


HILLVIEW ADDITION

D.L.C. 54, T.11S., R.5W., W.M. Benton County, Oregon



I, C. W. DANE, certify that I have correctly surveyed and marked with proper monuments the lands represented on this plat and, as an initial point for this survey, I drove a galvanized iron pipe, 2 inches in diameter and 36 inches long, 6 inches below the surface of the ground at a point 660.00 feet S 0° 19' E along the east claim line from the northeast corner of the John D. Mulkey D.L.C. 54, T.11 S., R.5W., W.M.. The lots and blocks are laid out on the following described tract of land:

Beginning at a 2 inch galvanized iron pipe which is S 0° 19' E 660.00 feet along the east claim line from the northeast corner of the John D. Mulkey D.L.C. 54, T.11 S., R.5W., W.M.; thence S 0° 19' E along said east claim line 222.49 feet to the northeast corner of Forest Acres; thence S 89° 57' W along the northern boundary of said Forest Acres 987.16 feet to a point; thence N 0° 19' W 403.816 feet to a point; thence N 89° 57' E 987.16 feet to said east claim line; thence S 0° 19' E along said east claim line 181.33 feet to the point of beginning.

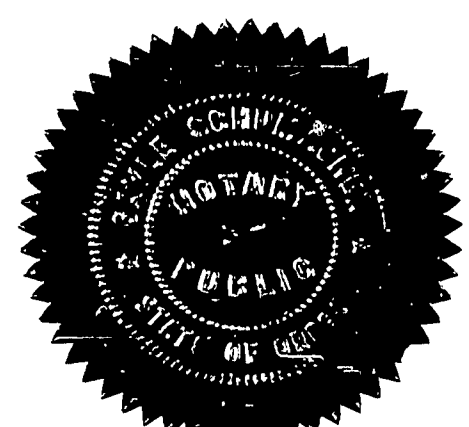
