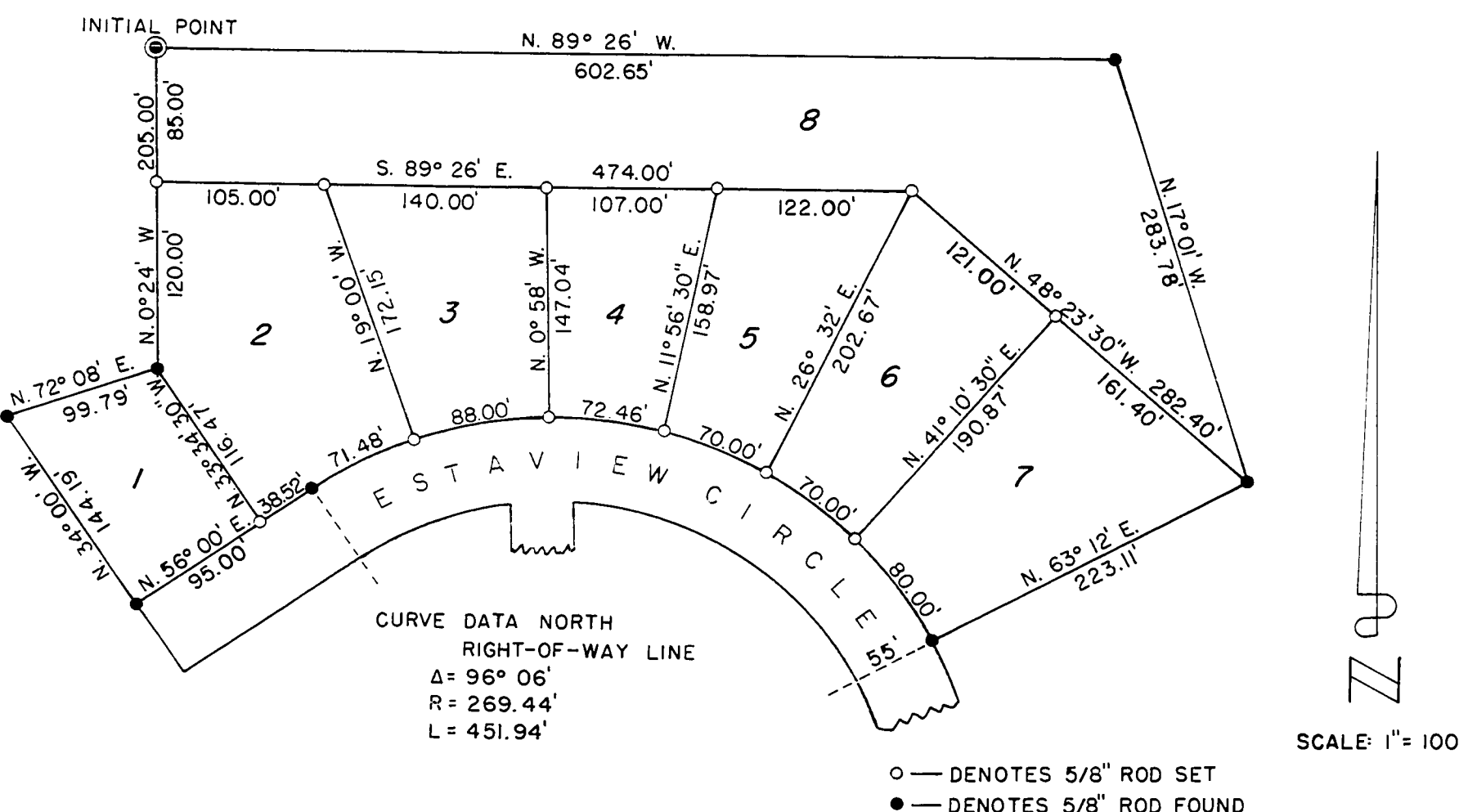


# SUPPLEMENTAL PLAT OF LOTS 34 TO 44 INCLUSIVE

I, Fred I. Lemke, being first duly sworn, depose and say that I have correctly surveyed and marked with proper monuments, the land represented on the plat hereon; that as an initial point of said survey I drove a galvanized iron pipe, 2 inches in diameter and 36 inches in length, 6 inches below the ground, said point being the northwest corner of EDGEWOOD PARK ESTATES SECOND ADDITION as platted and filed in Book 7 Page 3 Benton County Record of Plats; thence S. 89° 26' E. 602.65 feet to the northeast corner of Lot 42 of said subdivision; thence S. 17° 01' E. 283.78 feet to the southeast corner of Lot 43 of said subdivision; thence S. 63° 12' W. 223.11 feet to the northeasterly right of way line of Estaview Circle; thence along a 269.44 foot radius curve left (the chord of which bears N. 75° 57' W. 400.78 feet) a distance of 451.94 feet; thence S. 56° 00' W. 133.52 feet; thence N. 34° 00' W. 144.19 feet; thence N. 72° 08' E. 99.79 feet; thence N. 0° 24' W. 205.00 feet to the point of beginning.

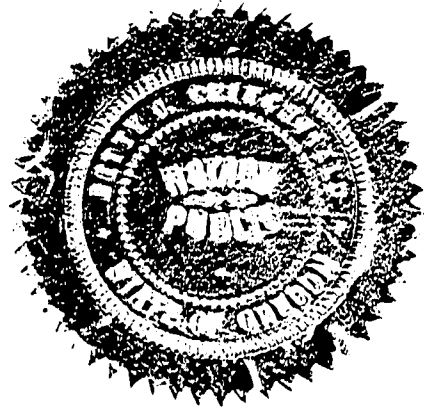
